#### Late Payment Fee:

\$27.00 or the amount of the required minimum payment, whichever is less, if you are one or more days late in making a payment. In the event you fail to make a payment on time in any of the six billing cycles following the initial violation, you will be charged \$30.00 or the amount of the required minimum payment, whichever is less.

#### Cash Advance Fee (Finance Charge):

\$10.00 or 2.00% of the amount of each cash advance, whichever is greater.

#### Returned Payment Fee:

\$27.00 or the amount of the required minimum payment, whichever is less.

#### Pay-by-Phone Fee:

\$5.00.

#### Rush Fee:

\$25.00.
